Gentlemen

A protest was filed pursuant to the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Rules") by Douglas Frechin In his protest, Mr Frechin claims that Brian Rothman, an alternate delegate to the 1991 IBT International Union Convention and a member of the Sergeant of Arms Committee, acted toward him in an allegedly intimidating and threatening manner

The 1991 IBT International Union Convention is now over Mr Frechin does not allege, and the Election Officer has found no evidence, that the alleged behavior of Mr Rothman interfered with Mr Frechin's participation in the proceedings of the Convention Nor does Mr Frechin allege, and the Election Officer does not find, that Mr Frechin and others with whom he is politically aligned were prevented by Mr Rothman's alleged actions from fully espousing their political positions at the Convention By reason of the foregoing, and given that the Convention is now concluded, the protest is deemed MOOT and dismissed on that basis

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal. Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693. Copies of the request for hearing must be served on the parties listed above, as well as upon the Election Officer, IBT, 25 Louisiana Avenue, N. W., Washington, D.C. 20001, Facsimile (202) 624-8792. A copy of the protest must accompany the request for a hearing.
