Gentlemen:

A pre-election protest was filed pursuant to Article XI of the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Election Rules"). protest, dated October 9, 1990, the complainant alleges that the Election Rules were violated by a notice of Nominations and Elections of Local Union 23 officers published in the September, 1990 edition of the Wisconsin Teamster. The September edition of the Wisconsin Teamster was distributed by mail to Teamster members, including members of Local 23, in mid September.

Based on the information available to the Election Officer it appears that the above referenced protest is untimely under Article XI, Section 1(a)(1) of the Election Rules. However, the ambiguity in the notice of local officer nominations and elections which was the subject of the protest has previously come to the attention of the Election Officer and steps have been taken to clarify the notice. Specifically, a correction to the nomination and election notice for Teamsters Local Union 23 has been posted on local union bulletin boards. In addition the correction was read by the local union Secretary-Treasurer at the Local Union nomination meeting for local union officers held on October 21, A copy of the correction is attached hereto for your information.

The corrective action taken by the local has, in the opinion of the Election Officer, clarified any ambiguity that may have been created by the local union notice. Therefore, no further action is necessary under the Election Rules.

CORRECTION TO NOMINATION AND ELECTION NOTICE FOR TEAMSTERS LOCAL UNION NO 23

The September issue of the <u>Wisconsin Teamster</u> ran a notice of nominations and election of officers for Local Union No 23. The final paragraph of the notice incorrectly stated that all officers elected in this election would be delegates to "all other conventions," which would include the International Convention to be held in June, 1991

By order of the Court in United States of America v. International Brotherhood of Teamsters, et al. delegates to this International Convention must be elected separately from local union officers. Nominations and election of delegates for Local Union No 23 to this Internat onal Convention will be held in the winter of 1991. Separate notice of this delegate election will be published prior to that time.
