## Gentlemen

This will acknowledge receipt of the above referenced pre-election protest filed pursuant to the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Rules") A copy of the protest is attached. The complainant alleges a delay in the posting of an Election Officer approved listing of nomination results, which was required to be posted as the result of my determination of a previous protest, until after a hearing by the Independent Administrator of an appeal by the Local Union For the reasons set forth below, the protest is denied

On October 3, 1990, Local Union 550 received a copy of the Election Officer's determination in case no P-002-LU550-NYC requiring the Local to remove its notice of nomination results and to post a notice approved by the Election Officer On the same day, the Secretary -Treasurer of the Local Union sent a letter to shop stewards instructing them to remove the defective notice and replace it with the Election Officer approved notice The Local Union took this action even though it intended to appeal the Election Officer's determination to the Independent Administrator A timely appeal was filed and my determination was upheld by the Independent Administrator

The Election Officer finds that Local Union 550 did not delay in complying with the remedy in P-002-LU550-NYC

If any interested party is not satisfied with this determination they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter Such request shall be made in writing and shall be served on
