Gentlemen

A pre-election protest was filed pursuant to Article XI, of the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Election Rules") In his protest, Douglas Frechin alleges that the Election Rules were violated by fellow employee Mark Johnson when he interfered with campaign related literature posted on the employee bulletin board of Yellow Freight System Mr Frechin also alleges that this conduct was encouraged by employer Yellow Freight System and by the Local Union 174

The investigation of this protest revealed the following facts Employees Douglas Frechin, Dean Ambler, Mark Johnson and Richard Kraft at all times material to this case were members of Local 174 employed by Yellow Freight at its Everett terminal Neither Johnson nor Ambler are officers or agents of Local Union 174

On or about September 1, 1990 Kraft purchased and installed an employee bulletin board in the break room of YFS Since that time Kraft and Frechin have used the bulletin board to post literature, some of which is election related Douglas Frechin November 29, 1990 Page 2

During the week of October 28, 1990, when Frechin and Kraft were absent from work, someone removed literature, some of which was election related which had been posted by Frechin There is no evidence as to who removed the literature Frechin later reposted his literature

On November 6, 1990 Dean Ambler and Mark Johnson covered all of Frechin's literature with newsprint However, they did not post any literature or announcements of their own On November 7, Dean Ambler removed and stacked all of Frechin's literature into one pile and reposted it Ambler did not post any literature or announcements in space he created on the board

The Election Officer found no evidence that the employer was aware of, authorized or ratified the conduct of Johnson and Ambler

Article VIII, Section 10(d) of the Election Rules states that "No restrictions shall be placed on candidates' or members pre-existing rights to use employer or Union bulletin boards for campaign publicity. Similarly, no restrictions shall be placed upon candidates' or members' pre-existing rights to solicit support, distribute leaflets or literature, conduct campaign rallies, hold fund raising events or engage in similar activities on employer or Union premises Such facilities and opportunities shall be made equally available on the same basis to all candidates and members " By covering over or rearranging Frechin's election related literature, Ambler and Johnson interfered with Frechin's rights to post election related material

To remedy this violation of the Election Rules, the Election Officer orders the enclosed notice to be posted on the aforementioned Union Bulletin Board at the Everett facility of the Yellow Freight System, and remain there for a period of thirty days Douglas Frechin November 29, 1990 Page 3

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent extraordinary circumstances, no party may rely on evidence that was not provided to the Regional Coordinator in any appeal of the Election Officer's determination regarding the protest.

ELECTION OFFICERS NOTICE

You have the right to campaign on behalf of any candidate for delegate or International Office

All candidates or their representatives have the right of equal access to post campaign literature in the places where any candidate has been permitted to post campaign literature

It is a violation of the Rules for the IBT International Union Delegate and Officer Election, Article VIII, Section 10 to interfere with the right of equal access by covering up, rearranging, or removing campaign literature

Any candidate or candidate representative denied access space on a bulletin board has the right to file a protest with the Election Office within 48 hours of being denied equal access.
