A pre-election protest was timely filed pursuant to Article XI of the Rules for the IBT International Union Delegate and Officer Election revised August 1 1990 (Election Rules) In his protest Rudy Hernandez alleges that the Election RUles were violated by the publication in the November 1990 issue of Northern California Teamster (Volume 35 No 8) an announcement of the Executive Board endorsement of R V Durham one of four announced candidates for the office of General President of the IBT The protest alleges that the pictures and endorsement announcements of other candidates campaigns have not been publicized by the newspaper

This case has been investigated by the Election Officer During the investigation, the Respondent informed the Election Officer by letter dated December 5 1990 that Joint Council 7 would provide coverage of the all other announced candidates for IBT General President in its January 1991 issue of the Northern California Teamster The article(s) will be comparable to the article that appeared covering R V Durham s cand dacy and will be accompanied by photographs of the same dimensions as the photograph of Mr Durham Further the article(s) will receive placement in the publication similar in prominence to the placement of the article here at issue and will appear on the front page of the publication Accordingly I am unilaterally accepting the Joint Council 7 s plan to publicize the candidacies of Walter Shea Louis Riga and Ron Carey as a settlement of this protest since I find that such a proposal effectuates the purpose of the Rules
