## Gentlemen

A pre-election protest was timely filed pursuant to Article XI of the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Rules") In his protest Steven Silverman contends that the Rules have been violated because the Declaration of Affiliation with a slate by Rank and File Representation was not properly filled out, and because Patrick McGrath, Mariano Ramos, Peter J. Lunde, and Irvin Johnson failed to submit original signed acceptance of nomination.

The investigation shows the following. At the time of the Local Union 810 nominations meeting member Patrick McGrath Mariano Ramos, Peter J. Lunde, and Irvin Johnson submitted letters of acceptance that contained photocopy signatures. The members were not in attendance at the meeting. The Election Officer representative accepted the letters, but requested originals to be submitted. The Rules permit written acceptance of nomination. Rules, Article II, § 3 (h). Subsequent to the meeting, Messrs. McGrath, Ramos, Lunde, and Johnson tendered original acceptances to the Regional Coordinator, Amy Gladstein, rather than to Mr. Silverman. The Election Officer has confirmed that each of these members intended to accept nomination for the position of delegate. Thus there is no violation of the Rules as to this aspect of the protest. The protest is DENIED.

Mr. Silverman also contends that the slate was improperly filled out The slate form was inspected by the Election Officer representative. It does not contain a number in the part of the form styled Number of Candidates, although the number is required Further, Mr. McGrath originally signed his name under the heading "Name of Candidate" as well as "Signature." Subsequently, his signature was removed in his presence under the column "Name of Candidate" and his name was reentered in that column in printed form The Election Officer has confirmed that the intent of the slate members was to field seven candidates and their failure to indicate this in the requisite portion of the form was inadvertent. Further the white-out changes were made in an effort to comply with the slate request that slate member names be designated in type or print and also by signature. For all the foregoing reasons, there has been no misrepresentation on the slate form which would violate the Rules. This aspect of the protest is DENIED.

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal. Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693. Copies of the request for hearing must be served on the parties listed above, as well as upon the
