## Gentlemen

A protest was filed with the Election Officer pursuant to Article XI of the Rules for the International Union Delegate and Officer Election, revised August 1, 1990 ("Rules") In his protest, Mr Tull alleges that the Rules were violated by Jim Boardman, a business representative for the Local Union, when Boardman distributed copies of the "Teamster Election News" inside the Local Union Hall The Election Officer's investigation of this protest revealed the following

The "Teamster Election News" is a four page tabloid published by RL Communications of Detroit, Michigan The publication is critical of Ron Carey and his candidacy for General President of the IBT.

In the instant protest, Mr Tull alleges that the "Teamster Election News" was handed out by Jim Boardman, a business representative of the Local Union, in the Local Union Hall in violation of Article VIII Section 10 of the Rules The incident in question occurred on the evening of January 4, 1991 The investigation revealed that Boardman, a full time employee of the Local Union, had taken vacation on the day of the incident Boardman received

several photo copies of the "Teamster Election News" from another business agent, Bob Hahn Hahn was a candidate for delegate on the "Ed Mireles Slate" Hahn found the photo copies of the publication on car windows in an employee parking lot at a UPS facility in Orange county

On the day of the incident, Boardman was at the Union Hall to attend a meeting and got into a conversation with William Tull and Charles Sciano, who were both candidates for delegate on a slate identified with Ron Carey During the conversation, Boardman asked the two whether they had seen "the latest stuff on Carey". Tull said no and asked to see a copy Boardman then gave Tull a photo copy of the tabloid

Article VIII, Section 10 of the *Rules* safeguards the right of all Union members to participate in campaign activities in support of, and in opposition to, any campaign or candidate for delegate or International Officer However subsection (b) of that section of the *Rules* prohibits Union members, who are employees of the Union, from engaging in non-incidental campaigning on work time Because Boardman was on vacation on the day of the incident, the Election Officer finds no violation of this provision of the *Rules* with respect to his campaign activity on that day

Article VIII, Section 10 (d) provides, inter alia, that no restrictions shall be placed on pre-existing rights to use Union premises for campaign purposes and that equal access shall be afforded to all candidates. There is no allegation that a short and casual conversation among Union members about the delegate and International officer campaigns which takes place inside of a Union Hall is campaigning or is otherwise violative of the *Rules*, and the Election Officer finds no such violation here

With respect to the alleged "distribution" of the photocopy of the "Teamster Election News" inside the Union Hall, the Election Officer finds that it involved the distribution of at most two copies of the literature. In fact, the protestor asked to see a copy of the literature and there is evidence that he asked to keep it. Moreover, there is no allegation that the protestor was denied an opportunity to engage in similar limited conversations and distributions inside the Local Union Hall

For the forgoing reasons, the instant protest is DENIED 1

Although not raised in this protest, the Election Officer, in the investigation of this protest, and other protests concerning the Teamster Election News, is examining the sources of funding of the publication and distribution of (continued)

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal. Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693. Copies of the request for hearing must be served on the parties listed above, as well as upon the Election Officer, IBT, 25 Louisiana Avenue, NW, Washington, D. C. 20001, Facsimile (202) 624-8792. A copy of the protest must accompany the request for a hearing
