Gentlemen:

A pre-election protest was timely filed pursuant to Article XI of the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Rules") In this protest Mr. Camarata alleges that the Rules have been violated because ballots have not been mailed to Local Union 299 members employed at Dollar Rent A Car at Detroit Metro Airport.

The investigation shows that Dollar Rent A Car is a successor employer. The previous employer had a dues check-off arrangement with Local Union 299. There was no successorship clause in the Labor Agreement, and the dues check-off arrangement has not been continued although Dollar is in collective bargaining negotiations with Local Union 299. None of the employees have elected to tender cash dues during the pending negotiations.

Since none of these employees are currently dues paying members of the Local, none are members in good standing with Local 299 and none are eligible to cast a ballot in the IBT election. The <u>Rules</u> have not been violated and the protest is DENIED

If any person is not satisfied with this determination, he may request a hearing before the Administrator within twenty-four (24) hours of his receipt of this letter. Such request shall be made in writing and shall be served on Administrator Frederick B.
