Gentlemen

A pre-election protest has been filed pursuant to Article XI of the <u>Rules for the IBT International Union Delegate and Officer Election</u>, revised August 1, 1990. The Complainant, Vincent Meredith, seeks to make a pre-election mailing to all or some Local Union members pursuant to Article VIII, Section 6 of the Rules. His protest contends that the Local has deliberately sought to delay and interfere with the mailing.

On November 8, 1990, Mr. Meredith wrote to Charles Spond, the Secretary-Treasurer of Local 89, involving his right to make a mailing to Union members at his own expense. In the letter, Mr. Meredith specifically outlined the procedures he desired to be used with the mailing He asked that the Local inform him immediately of the procedures which would be used, including, costs and times and dates. This letter was delivered to the Local on the next day.

On November 12, 1990, Local Secretary-Treasurer Spond wrote back to Mr. Meredith, stating that the Local was "exploring" methods for obtaining a mailing service for literature distribution. On November 27, 1990, he wrote a second letter to Mr. Vincent, in response to an oral inquiry, and stated that the Local was "searching" for a Company to handle a candidate mailing. On December 14, 1990, the Local informed Mr. Meredith that it was continuing "to check" various sources for the mailing of campaign literature. On that day, 36 days after the initial request was mailed, the Local sent quotes from various companies to Mr. Meredith regarding literature mailing. It appears that the Local was able to obtain a final price quote for Mr. Meredith on December 21, 1990, 43 days after the request was made by Mr. Meredith.

As of the present date, it appears that the Local has made it possible for Mr. Meredith to complete his mailing, which he desires to make at the beginning of February 1991 It appears, however, that the Local delayed what should be a simple process unnecessarily Only Mr Vincent's early start and diligence has ensured that he is in a position to make his mailing in a timely fashion The Union's delay was unreasonable under Article VIII, § 6 of the Rules

Accordingly, the Election Officer finds that Local 89 has violated the Election Rules by its attempt to interfere with Mr Meredith's right to use his own resources to make a mailing to Local members

The Local is directed to post the Notice attached hereto at each location where it represents employees.

If any person is not satisfied with this determination, he may request a hearing before the Administrator within twenty-four (24) hours of his receipt of this letter. Such request shall be made in writing and shall be served on Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, N J 07102-5311, Facsimile (201) 622-6693. Copies of the request for hearing must be served on the parties listed above as well as upon the Election Officer, IBT, 25 Louisiana Avenue, N W, Washington, D C 20001, Facsimile (202) 624-8792. A copy of the protest must accompany the request for a hearing The parties are reminded that absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal.

DECISION OF THE INDEPENDENT ADMINISTRATOR

This matter arises out of an appeal from the January 16, it

1991, decision of the Election Officer in Election Officer Case

No. On January 22, 1991, a hearing was held

before me by way of teleconference during which the following

persons were heard: Vincent L. Meredith, the complainant;

Charles L. Spond, Jr., on behalf of IBT Local Union 89 (the

"Local"), the appellant; John Sullivan, on behalf of the Election

Officer; and Peggy Hillman, the Regional Coordinator.

In his protest, Mr. Meredith, a candidate for delegate to the 1991 IBT Convention on behalf of the Local on the "rank and file" slate, contended that the Local had deliberately sought to delay and interfere with his pre-election mailing of campaign literature as authorized by Article III, Section 6 of the Rules For The IBT International Union Delegate And Officer Election (the "Election Rules").

As of the present date, it appears that the Local has made it possible for Mr. Meredith to complete his mailing, which he desires to make at the beginning of February, 1991. At issue is the delay experienced by Mr. Meredith in receiving information from the Local regarding the cost of the mailing. From the time of his initial request, until he received all the information needed regarding the mailing, some 50 days passed. During this 50-day period, Mr. Meredith's campaign was virtually halted due to the fact that he could not spend any of his limited campaign funds until he determined how much the mailing would cost him.

The Local contends that it did not act intentionally and complied with Mr. Meredith's request as expeditiously as possible.

While the Local could have provided Mr. Meredith with information regarding the cost of mailing sooner than it did, I am not convinced that it acted deliberately to thwart Mr. Meredith's campaign. In fact, when called on December 21, 1990, by Mr. Meredith, Mr. Spond agreed to meet with him the very next day at 8:30 a.m. to share information with him. I do recognize, however, that the Local's responsiveness to Mr. Meredith followed the filing of his protest and was prompted, in great part, by Mr. Meredith's own tenacity.

Notwithstanding my finding that the Local did not act deliberately, I do find that confusion may now exist regarding the Local's responsibility, pursuant to Article VIII, Section 6

of the Election Rules. To cure such confusion, I direct the attached notice to be signed by the President of the Local, Norman C. Hug, to be posted at each location where it represents employees. Such notice shall remain posted for thirty days.

Gentlemen.

A pre-election protest has been filed pursuant to Article XI of the <u>Rules for the IBT International Union Delegate and Officer Election</u>, revised August 1, 1990 The Complainant, Richard Hofman seeks election as a delegate to the IBT International Convention He seeks designation on the ballot as a member of a slate, but would be the only member of that slate running for delegate. He protests the decision of the Regional Coordinator which did not allow him to be designated as a member of a slate.

The <u>Rules</u> do not allow "one person slates." The <u>Rules</u> define slate as "any grouping by mutual consent of two or more candidates." <u>Rules</u>, Definitions, 35 (emphasis added). Further, all other <u>Rules</u> that refer to slates also refer to slates of "candidates" See <u>Rules</u>, Article II, Section 7, Article II, Section 8; Article VII, Section 1

For these reasons, the protest is DENIED

Gentlemen:

A protest has been filed with the Election Officer pursuant to Article XI of the Rules for the International Union Delegate and Officer Election, revised August 1, 1990 ("Rules"). In his protest, James C. Pegelow alleges that the Rules were violated as a result of the mailing of copies of the "Teamster Election News" to Local Union 638 shop stewards. The Election Officer's investigation of this protest revealed the following.

The "Teamster Election News" is a four page tabloid published by RL Communications of Detroit Michigan. The publication is critical of Ron Carey and his candidacy for General President of the IBT.

In the instant protest, Mr. Pegelow alleges that Local Union 638 shop stewards received copies of the "Teamster Election News" and that is has been "put out by the union and or the various employers". The investigation revealed that copies of the "Teamster Election News" were mailed to shop stewards at their homes. The envelope containing the tabloid did not have a return address and at least one envelope had a Minneapolis, Minnesota post mark. The Election Officer discovered no evidence that the Local Union either paid for the mailing or the material distributed

The Election Officer is continuing, however, to investigate the source of funding utilized by R L Communications, publisher of "Teamster Election News" with respect to its preparation, publication and distribution of "Teamster
