Gentlemen

A pre-election protest has been filed pursuant to Article XI of the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Rules"). The Complainant, E Keith Caton, complains about a newspaper article which was published in the general circulation newspaper, The Spotlight, which is published in Indianapolis, Indiana

The Election Office was provided with an original copy of the newspaper page in question. On page 2 of the January 9, 1991 newspaper, there is an article whose headline reads "Teamsters Local 135 Back Carey." The basis for this headline is the first paragraph of the story, which reads: "Thirty working rank and file members of Indiana Local 135 have formed a slate called the Indiana Teamsters Slate for Ron Carey."

The basis for the protest is that the headline is inaccurate. that Teamsters Local 135 has not decided to back Ron Carey The Complainant attributes the headline to a Mr Bobby Andrews, another member of Local 135 who allegedly placed the article in the newspaper

There is no evidence that the member who caused the article to be placed in *The Spotlight* had any responsibility for drafting the headline for the article. Virtually all newspapers draft their own headlines. Thus, the alleged inaccuracy in the headline is something for which Mr Andrews can not be held responsible.

Accordingly, the protest is DENIED

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter.
