Gentlemen.

A pre-election protest was timely filed pursuant to Article XI, Section 1 of the *Rules for the IBT International Union Delegate and Officer Election*, revised August 1, 1990 ("*Rules*"). In his protest, Mr Richard F. Wojciechowski alleges that he was verbally threatened by Ronald Prunesti, President of Local Union 102 and a candidate for delegate, because of his election campaign activity.

The investigation shows the following. The incident which forms the basis for this protest took place on Saturday, February 2, 1991, during a shift meeting of ten to fifteen Local 102 members The meeting was called by Local 102 President Ronald Prunesti in order to discuss the recently rejected Anheuser-Busch contract and to respond to a petition which had been circulated by Local 102 members requesting such a meeting

After the Anheuser-Busch contract was rejected, Local 102 members, including Mr Wojciechowski circulated petitions calling for more information about the contract and the convening of a Local meeting to discuss the contract decision. Mr. Prunesti was upset about the petitions because Mr Wojciechowski submitted the petitions to the International rather than to the Local.

At the February 2, 1991 meeting, Mr Prunesti asked who had circulated the petitions and why they had been submitted to the International. Mr. Wojciechowski claimed responsibility. During the ensuing discussion between Messrs. Prunesti and Wojciechowski, someone else in the group asked a question. When Mr. Prunesti turned to answer the question, Mr. Wojciechowski also commented on the question Mr. Prunesti then turned to Mr. Wojciechowski, and said, "I will take care of you later."

Mr Wojciechowski said nothing, but another member, John Daplans, asked Mr. Prunesti if Mr Prunesti realized that he had threatened Mr Wojciechowski. Mr Prunesti states that he answered "no" and then responded to the question posed by the other member This was the only interaction between Mr Prunesti and Mr Wojciechowski.

Mr Prunesti does not deny making the statement, but he and other witnesses attending the meeting believe the statement was taken out of context and misinterpreted

There was no physical contact between Mr. Prunesti and Mr. Wojciechowski before, during, or after this statement Mr Wojciechowski told the Election Officer that he did not feel physically threatened at the time of the meeting, but that he felt threatened when his employer disciplined him some days later. Mr. Wojciechowski believes that Mr. Prunesti influenced the employer to issue the discipline.

A few days later, Mr Wojciechowski's supervisor gave him a verbal warning regarding the length of the breaks he was taking Mr Wojciechowski states that his breaks are no longer than breaks of any other member of his shift, but no other employee received such a warning

There is no other evidence, however independent of the warning, to show that the employer disciplined Mr. Wojciechowski because of his campaign activity. Nor is there evidence to show collusion between the employer and Local 102, or the employer and Mr Prunesti.

Based on the foregoing, the Election Officer concludes that the evidence does not support a finding that the *Rules* have been violated. The dispute between Messrs. Prunesti and Wojciechowski was related to the Anheuser-Busch contract, not to delegate campaigning Further, the evidence is not clear that the statement made by Mr Prunesti was intended as a threat, and Mr. Wojciechowski states that he did not take the statement as a threat at the time of the meeting. Additionally there is an absence of evidence linking the Local with the discipline issued by the Employer.

The Election Officer concludes further, however, that in the interest of ensuring open, honest and fair elections, a restatement of the rights of candidates and members to participate in the IBT elections should be promulgated. Therefore, the Election Officer orders Local 102 to post the attached Notice on all Union bulletin boards at each of the work sites where the Local represents members The Secretary-Treasurer of the Local shall submit an affidavit to the Election Officer no later than March 7, 1991 averring that such Notice has been posted.

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal. Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby (
