Gentlemen

A pre-election protest was filed pursuant to Article XI, § 1 of the Rules for the IBT International Union Delegate and Officer Election, revised August 1990 ("Rules") by Ott L Rogers, Secretary-Treasurer of Local Union 373. Mr. Rogers alleges that a "sample ballot" being distributed by Bob Highfill on behalf of the Teamsters for Change Slate" violates the Rules. The Election Officer has investigated the allegations underlying this protest and makes the following findings. Complainant has attached a copy of the sample ballot which he claims offends the Rules. Inspection of this sample ballot reveals that the statement "sample ballot only" is printed clearly and visibly on the document. The word "samples" appears in handwriting in two places on the ballot. Mr. Rogers' specific complaint is that his name and the name of his slate has been deleted from the document and replaced by the statement "Same Old Thing Slate." The names of individual candidates are removed and the same phrase appears opposite the checkoff box These alterations of the sample ballot demonstrate the ballot is being utilized by the opposing slate and Mr. Highfill as a piece of campaign literature.

The Rules, specifically Article VIII, § 10 secure for all candidates the freedom to fully exercise political rights through solicitations, support and the distribution of campaign literature. The Election Officer has consistently applied the Rules so as to safeguard the exercise of these political rights. The Rules neither prohibit nor regulate the content of campaign literature. The sample ballot to which Complainant Rogers objects is not deceptive or misleading and it is clearly campaign literature to the reader.

Accordingly, the protest is DENIED

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent administrator, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal. Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B.
