Gentlemen:

A protest was filed pursuant to the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Rules"), a copy of which a protest is enclosed. This matter concerns Derek Brown's protest of the Election Officer's certification of the election results in Local Union 85.

The Rules provide in Article XII, §7(a) that the Election Officer shall certify the results of the delegate and alternate delegate election after completion of the election process where no timely objections to the election are raised or, assuming such an objection, upon the completion of the protest and appeal procedure. An objection to the delegate and alternate delegate election in Local Union 85 was filed by Mr. Brown, the protestor here. Election Office Case No. Post-55-LU85-CSF. On April 19, 1991 the

Election Officer issued his decision denying that protest. The Election Officer decision was affirmed by the Independent Administrator on May 7, 1991. 91-Elec.App.-145 (S.A.). Under these circumstances it was appropriate, and indeed required by the Rules, for the Election Officer to certify the results of the delegate and alternate delegate elections with respect to Local Union 85.

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal. Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693. Copies of the request for hearing must be served on the parties listed above, as well as upon the Election Officer, IBT, 25 Louisiana Avenue, N.W., Washington, D.C. 20001, Facsimile (202) 624-8792. A copy of the protest must accompany the request for a hearing.
