Gentlemen:

A protest was filed pursuant to the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Rules") by Steve MacDonald, a certified delegate to the 1991 IBT International Union Convention from Local Union 490. In his protest, Mr. MacDonald contends that Local Union 490 is violating the Rules with respect to its policy regarding expense reimbursement of its delegates attending the 1991 Convention.

The Rules, as further explicated by the Advisory Regarding Convention Expenses, issued April 19, 1991 ("Advisory"), requires Local Unions to pay the expenses of their delegates, and, if applicable, their alternate delegates to attend the 1991 IBT International Union Convention. The expenses for which the Local Union is responsible include: (1) travel expenses, (2) hotel room expenses, (3) per diem advances, and (4) salary or

wage reimbursement. With respect to per diem advances, the Advisory provides that the Election Officer considers \$130.00 per day to be reasonable. This is the amount paid by the International Union for per diem expenses, which are in addition to the amount paid by the International Union for lodging and travel costs. The Election Officer deems per diem expense advances of less than \$130.00 per day to be unreasonable.

Thus, the policy of the Executive Board of Local 490 limiting per diem expenses to \$60.00 per day violates the *Rules*. Local Union 490 must provide expense advances of \$130.00 per day to its delegates. All such expense monies must be utilized for Convention related expenses, as documented by receipts. All expense monies advanced, not documented by receipts, must be returned to the Local Union after the Convention.

The Advisory further provides that it is unreasonable for the Local Union to refuse to advance per diem expense money to its delegates. Thus, upon request of a delegate, the Local is obligated to advance up to the full amount of all daily expense allowances, at the \$130.00 per day, in accordance with the delegate's request.

Per diem expense monies are to be utilized for any and all Convention related expenses not otherwise paid by the Local Union. Among such expenses are local transportation costs in and around the Convention site. Thus, the cost of renting an automobile for Convention related travel in Orlando, Florida is properly chargeable against per diem expenses.

The protest of Mr. MacDonald is granted to the extent set forth above.

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24)

This matter arises out of an appeal from a decision of the Election Officer in Case No. P-799-LU490-CSF. A hearing was held before me on June 19, 1991. At that hearing, Casey Sawyer, Secretary-Treasurer of Local 490 was heard via telephone conference and John J. Sullivan, on behalf of the Election Office, was heard in person.

This matter concerns the Election Officer's "Advisory Regarding Convention Expenses" ("Advisory"). In the Advisory, the Election Officer states that a one hundred thirty dollar per diem payment is a reasonable daily allowance for delegate expenses during the Convention. In reviewing the Advisory in the matter of <u>In Re: Hasegawa</u>, 91 - Elec. App. - 156 (SA) (June 6, 1991), the Independent Administrator stated as follows:

> The Advisory reflects a well-reasoned approach to regulating a Local Union's obligation to defer the expenses of delegates and alternate delegates attending the IBT Convention as well as the Local's obligation in regards to compensating delegates and alternate delegates for their lost wages while attending the Convention. The Advisory is consistent with the <u>Rules For The IBT International Union</u> <u>Delegate And Officer Election</u> ("Election Rules") and reflect the Election Officer's expertise. The Advisory is deserving of great

deference and its directives will not be disturbed. In short, any appeals regarding the substance of the Advisory will be summarily denied. Appeals concerning the application of the Advisory's directives, however, will, of course, be considered in due course.

Local 490 challenges the one hundred thirty dollar per diem amount arguing that it is excessive and that a more reasonable per diem amount would be sixty dollars. The Local indicates that it does not want to pay for delegates' alcohol or dinner guests.

The concerns of the Local here are premature. As stated in <u>In</u> <u>Re: Hasegawa</u>, the substance of the Advisory will not be disturbed. Local 460 must issue to its delegates the per diem of one hundred thirty dollars.

Pursuant to the Advisory, however, all delegates must supply to the Local receipts documenting all of their expenditures and return to the Local any monies not accounted for. The Local, at the time it receives these receipts, will have the right to challenge any expenditure as unreasonable. The Election Officer, however, is not currently obligated to issue additional advisory opinions as to what may constitute an unreasonable expenditure.

For the reasons expressed herein, the Election Officer's decision is affirmed.
