Gentlemen

A post-election protest was filed by Mr Edward G Tyler on March 5, 1991 pursuant to the *Rules for the IBT International Union Delegate and Officer Election*, revised August 1, 1990 ("*Rules*"), alleging that the winning slate in the Local 227 elections for one delegate and one alternate had received improper financial support from the Teamsters for a Democratic Union (TDU) Mr Tyler contends that such support constituted inappropriate employer contributions for candidates in the IBT delegate and alternate election in violation of the *Rules*

The initial election count in Local 227 took place on March 5, 1991, and a recount took place on March 8, 1991 Five hundred and sixty-eight (568) ballots were cast, with 36 challenged ballots The results of the election were as follows

Thus, the margin of victory in the delegate race was nine votes, while the margin was 20 votes in the alternate race

The unsuccessful delegate and alternate candidates, running as the Tyler/Larson Slate protest their opponents' alleged receipt of financial support from TDU, contending that this support constituted inappropriate employer support The *Rules* prohibit any candidate from accepting or using campaign contributions from an employer, the Union or any other labor organization *Rules*, Article X, § 1(b). The members of the Odegard/McGowan Slate deny receipt of any financial support or contributions of any kind from TDU

The investigation conducted by representatives of the Election Officer does not show that the Odegard/McGowan Slate received any monetary contributions from TDU The investigation further confirmed the lack of any other TDU assistance to Messrs Odegard or McGowan While the members of the Odegard/McGowan Slate distributed two flyers, those flyers were composed, printed and distributed solely by Messrs Odegard and McGowan and their supporters No prototype flyer or other assistance was requested or provided by TDU to the Odegard/McGowan Slate with regard to the production and distribution of any campaign literature Additionally, no other support was requested of or provided by TDU to the Odegard and McGowan slate or their campaign Consequently, since no contribution was received by the Odegard/McGowan Slate from TDU, there is no factual basis for the post-election protest

Based on the foregoing, the protest of Mr. Tyler is DENIED.

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693 Copies of the request for hearing must be served on the parties listed above, as well as upon the Election Officer, IBT, 25 Louisiana Avenue, N W, Washington, D C. 20001, Facsimile (202) 624-8792.
