Gentlemen.

A post-election protest was filed under Article XI, § 1 of the Rules for the IBT International Union Delegate and Officer Election, revised August 1, 1990 ("Rules") by Joseph F Bennetta, a candidate for delegate from Local Union 191 Mr Bennetta contends that during the ballot count on March 7, 1991 the Election Officer representative improperly ruled that individuals who had paid dues but had not completed paying their initiation fee ineligible to vote 1

The protest of Mr Bennetta was the only post-election protest filed in connection with the Local 191 delegate election Mr James Stacy, a successful candidate for delegate from Local 191, filed a complaint with the Election Officer stating that the Local had failed to post a copy of the official election tally sheet on all Local Union bulletin boards within the time period prescribed in the Rules Mr. Stacy has advised

The Local Union 191 delegate election was conducted exclusively by mail ballot. 897 members returned their ballots 18 ballots were not counted as void and 121 ballots were challenged and the challenges sustained Therefore, 758 ballots were actually counted. Local 191 was required to elect 3 delegates and 3 alternate delegates to IBT International Convention. The tally of ballots was as follows:

Thus, the margin between the third ranked delegate candidate and the fourth ranked delegate candidate was 59 votes. Mr Bennetta was the sixth ranked delegate candidate, having received 305 votes. The margin between the third ranked alternate delegate candidate and the fourth ranked alternate delegate candidate was 75 votes.

Voter eligibility for mail ballot elections is determined as of the date when the mail ballots are counted, not as of the date the vote was cast or mailed. To be eligible to vote, a member must be a member in good standing of the Local Union, having paid the required initiation fee and having paid dues through the month prior to the month of the election. Payment of the full initiation fee is a pre-requisite to membership in good standing in the Local Union. New applicants who have not paid their full initiation fee are not members of the Local and therefore are not eligible to vote. Although Mr

that he wishes to withdraw his complaint as the official election tally sheet was posted after Mr Stacy had sent his complaint to the Election Officer. Thus, the Election Officer considers the complaint of Mr Stacy resolved

Bennetta argues that the Local considers new applicants to be eligible to vote if the member is paying the initiation fee in installments, this practice is not in accord with the IBT Constitution or the *Rules*.

The investigation conducted by the Election Officer has revealed that of the 121 ballot challenges that were sustained, only 30 were sustained on the basis of non-payment of the full initiation fee to the Local As noted above, the Election Officer affirms the determination that members were not eligible to vote. In any event, the number of members who were deemed not eligible for the reason of not having paid the full initiation fee is insufficient to affect the outcome of the Election Accordingly, the protest is DENIED.

If any interested party is not satisfied with this determination, they may request a hearing before the Independent Administrator within twenty-four (24) hours of their receipt of this letter. The parties are reminded that, absent extraordinary circumstances, no party may rely upon evidence that was not presented to the Office of the Election Officer in any such appeal. Requests for a hearing shall be made in writing, and shall be served on Independent Administrator Frederick B. Lacey at LeBoeuf, Lamb, Leiby & MacRae, One Gateway Center, Newark, New Jersey 07102-5311, Facsimile (201) 622-6693. Copies of the request for hearing must be served on the parties listed above, as well as upon the Election Officer, IBT, 25 Louisiana Avenue, N. W., Washington, D.C. 20001, Facsimile (202) 624-8792. A copy of the protest must accompany the request for a hearing.
